REGULAR TOWN COUNCIL MEETING  
May 18th, 2020

The Regular Council meeting of the Town Council of Clear Lake, Indiana was held at the Town Hall and by teleconference on Monday, May 18th, 2020 at 7:00PM. Present were Town Council Vice President Darin Thorp, Council Members Bonnie Brown, Brent Schlosser, and Tyson Johnston. Also present were Clerk/Treasurer - Jessica Swander. There were no property owners who signed the guest register and three joined via teleconference.

Council Vice President Darin Thorp called the meeting to order at 7:00 p.m. and waived the sighting of the Pledge of Allegiance.

COUNCIL ACTIONS:


