Wasterwater Project Update

It doesn't seem possible but here it is October. Docks are coming out, friends are departing for the winter and the kids have been back in school for a month. It was a little cool and wet this summer, especially on the weekends, but enjoyable. I would like to bring you up to date on what has been happening with the wastewater project.

We have hired our financial advisor for the project. After interviewing three excellent firms we have selected H. J. Umbaugh & Associates who has offices in Plymouth and Indianapolis. We will be working with the Plymouth office. Umbaugh will be finalizing costs along with plans and specifications that will be sent to IDEM. We have been notified that we will be receiving a \$500,000 loan from the state to offset our preliminary costs.

You will be seeing many small flags and painted lines around the lake. These are to mark the location of utility lines and should not be disturbed.

A complete recap of the project status and what is to come will be in the next newsletter that you will receive in early January 2001.



Clear Lake To Get Town-Wide Sewer

he citizens of Clear Lake acting through their Town Council have begun the process of constructing a sewer connecting all the cottages to the Town of Fremont where the effluent will be processed. In one basic step the citizens have reaffirmed their belief that Clear Lake must be preserved.

The machinery has been set in motion that will result in every cottage connecting to the sewer and eliminating any possibility of leaching from septic tanks into the Lake. This action will help preserve this beautiful lake for our children and grandchildren. This is the most basic conservation step of all. There are many details to be worked out but the expectation is that the town will have a working sewer by late 2002.

The citizens of Clear lake decided that the time to begin is now; not in the future when the lake quality will have degraded some; not in the future when the price of the project will have increased; not in the future when the hope is that we can get along without doing anything. The situation here at Clear Lake demanded action and the citizens wisely heeded the warnings and began this momentous project.



CLTLC Reaches GoalBegins New Fund Drive


