# Marshal's Page

Boating season is just around the corner. Below are some suggestions to ensure that you are prepared:

- 1. Be sure that you have your current Excise decals on your boats. *This includes sailboats as well as motorboats*.
- 2. Check to be sure that you have enough wearable Personal Flotation Devices on board and that they are sized for the occupants of the boat.
- 3. Check all required lights to be sure they are in working order.
- 4. If you have a detachable stern light, be sure it is in the boat. Make sure that anyone who operates your boat after sunset knows the location of the stern light.
- 5. A copy of the current Sunrise/Sunset timetable is available at the Town Hall. I would encourage every Clear Lake Resident to have one of these at the lake.

#### **Boater Education Class**

The class requires a minimum of 10 (ten) students. Minimum age for the class is 12 years. Anyone interested should contact <u>Dick Lehman at 260 495-9620</u> as soon as possible. The class will be held in June with the dates to be determined.

## **Wastewater Update**

The sewer system is working and ready for hook ups. Permits can be obtained at the town hall.

Sewer hookups must be completed by December of 2004.
