Update on Fremont Sewer Rate Increase and IURC Petition

In early March, the Fremont Town Council adopted a 36.5% increase in the rates it charges to Clear Lake and surrounding customers. As a result of this proposed increase, Clear Lake Town Council asked Fremont for further clarification as to how the current and proposed rates compare to other Fremont Sewer customers. On March 29, 2017, Clear Lake filed a petition with the Indiana Utility Regulatory Commission (IURC), an entity who advocates on behalf of utility customers, requesting a review of the rates and charges to Clear Lake for wholesale sewage treatment by Fremont.

Clear Lake and another Fremont sewer customer, The Steuben Lakes Regional Waste District (Steuben Lakes RWD), contend that Fremont was already charging rates which were greater than those permitted by Fremont's own ordinance. Clear Lake and Steuben Lakes RWD assert that both entities are entitled to **wholesale** sewage rates vs. **residential** sewage rates because Clear Lake takes care of installing, repairing and maintaining individual homeowner grinder pumps, processing and delivering its sewage as a wholesale customer. Clear Lake and Steuben Lakes RWD also contend that Fremont's increase exceeded those permitted by state statute for out-of-town customers.

The petition also requested a review of rates and charges which Fremont makes to customers within Clear Lake, all of whom are surcharged an additional 50% because their properties are located outside Fremont. On May 12, 2017, Clear Lake and Steuben Lakes RWD filed a petition with the IURC which requires Fremont to file any motion to dismiss by June 21, 2017 (*results not available at press time*), and Clear Lake, Steuben Lakes Regional Waste District, and the IURC to file their responses by July 21. Fremont will have an opportunity to reply to the procedural matters until August 11. Further update will be provided following the IURC's determination on the procedural issues.

Clear Lake Extra Territorial Jurisdiction (ETJ)

What It Is and Why Does It Matter?

Indiana Code provides municipalities with the ability for zoning and planning for an area up to two miles outside their corporate boundaries. When authorized by the county legislative body, the municipal plan commission and board of zoning appeals, assumes Extra Territorial Jurisdiction (ETJ) over this area to plan for the future of the community. The Proposed ETJ process is NOT annexation – it does not give taxation powers over the ETJ areas. It does not require the Town of Clear Lake to provide services such as sewer service, trash pick-up, or leaf pick-up to the Proposed ETJ area. ONLY planning and zoning would be affected.

Why does the Town of Clear Lake want Steuben County to authorize an ETJ?

The proposed ETJ is being considered for one main purpose: to give the Town of Clear Lake the ability to oversee the zoning and planning of the Clear Lake Watershed. That is the water that flows into Clear Lake.

What happens to the properties that fall within the Proposed ETJ?

If your property already falls within the Town limits, there is no impact to your property. If approved for properties in the ETJ, planning and zoning approval will be provided by the Clear Lake Plan Commission and BZA rather than the Steuben County Plan Commission and BZA. In addition, both the Clear Lake Plan Commission and Clear Lake BZA would be required to add members from the affected ETJ areas. A Reminder from the Sewer Department

We would like to remind home owners to take a look at the plantings around your grinder pumps. We know that everyone would like to hide that ugly old sewer grinder in their yard, but please try to look at it from the perspective of the people who have to work on them. We have found bushes grown so tight around the control boxes that they couldn't be opened. These control boxes contain HIGH VOLTAGE electricity that powers your grinders, which can pose a danger if plantings obstruct workers' access. Plantings can also make it difficult to find the control box quickly when the alarm is activated. Flower beds around the grinders, although pleasant to look at, can be infested with bees that are another safety issue. If you have Pampas grass or any other plantings within the five-foot radius of the grinder or any objects on top of your grinders, these need to be removed. When the sewer worker is called out to change the grinder at your house (usually after regular working hours), it would make the process quicker and safer if they have a clear working area. REMEMBER: If your grinder is not working, your waste water is not being pumped from your home to the lift station at the Town Hall and then on to Fremont. You need to **STOP RUNNING WATER** for any and all of your daily activities or you will have **BROWN WATER** in your lawn! So for the health and safety of all concerned, please take a close look at what's around your grinder pump.

Thinking of making some improvements on your property? You are invited to discuss any new projects you are planning on undertaking at your property that will happen outside your house. In most cases, an Improvement Location Permit from the town is required in order to obtain a building permit through Steuben County and one is required for flatwork (like driveways) and generators. Zoning Administrator Kenneth Hughes has regular office hours on Thursdays from 1-4pm at Town Hall and you are encouraged to make an appointment. - On the water, be mindful of speeds around buoys, fishermen and other boaters on the lake. Please be courteous, even if others aren't.

- Remember to lock your vehicles and place valuables out of sight.
- Lock your residence and outbuildings when unattended.
- Please try to introduce yourselves to neighbors in either direction from your residence and keep an eye on each other. Report strange or suspicious activity immediately, as it is occurring, to Steuben County Communications at **260-665-3131**, and they will assign the closest on-duty police officer.
- Check golf cart registrations for expiration and contact the town hall for us to renew or register one.

The compost facility will accept:

- grass clippings
- leaves
- brush

However, the compost facility cannot accept stumps or land clearing materials. The Steuben County facility is open Monday through Friday from 8:00 AM until 7:00 PM and Saturday from 8:00 AM until 3:00 PM. For more information, call 260-587-3063 or email www.niswmd.org.
